The Tisch MS Research Center's mission is to conduct medical research directed toward finding the cause and eventual cure of multiple sclerosis. Some of the program accomplishments include the following: we have made advances in our stem cell research. In 2015 we completed 75% of the FDA-approved phase I clinical trial testing stem cells in MS patients. Dr. Harris and Dr. Sadiq published an invited editorial discussing future perspectives of stem cell research in MS. We have made advances in our biomarker research, and Dr. Harris, Dr. Mir, Dr. Liu, and Dr. Sadiq have all presented abstracts at the American Academy of Neurology Conference in Washington DC describing novel cerebrospinal fluid biomarkers. Additional advances were made in understanding mechanisms of disease progression and Drs. Cristofanilli and Sadiq have presented abstracts at the American Academy of Neurology Conference describing immune activation in a novel experimental model of progressive MS. Also, Mr. Lin and Dr. Sadiq have presented an abstract at the American Academy of Neurology Conference describing their investigation of the cause of MS.

As an academic facility, The Tisch MS Research Center provides educational and training resources for MS researchers and medical professionals. Fellowships in MS research are offered to physicians and scientists interested in entering or expanding their work in this field. The Center had one publication in 2015, an editorial publication in neurodegenerative disease management discussing future perspectives of stem cell research for the treatment of multiple sclerosis.
